Minutes of Full Council held on 16th September 2025 in Frampton Village Hall.
Meeting commenced at 7.00pm.

FULL COUNCIL

1. Apologies for absence

Cllr David Nutt and Cllr David Taylor sent apologies.

2. Declarations of pecuniary or other interests

Cllr Antram declared an interest in agenda item 8a.

3. To approve the minutes of the Parish Council Meeting held on 15th July 2025

These were approved as a true and accurate record of the meeting.

4. Matters from the previous meeting

There were no matters arising. The Clerk did mention that DTAG were giving a briefing at Stratton on 17th September. He would feedback any useful information.

5. Chair's update

The Chair had no matters that were not on the agenda.

6. Public discussion period (agenda items)

There was much discussion on the Local Plan (see agenda item 10).

Concerns were raised on speeding through the village (see agenda item 13).

7. To receive a report from the Dorset Council

There was no report from the Ward Councillor.

8. To receive brief holder updates and to agree action(s) in response to proposals and repairs Allotments

Cllr P Taylor had no issues, although it was noted that one plot had not been worked whilst another was overgrown. This was to be reviewed at a later date.

Burial Ground

Cllr Adler had no concerns, but it was advised that an interment was scheduled.

Play Park

Cllr Purse had no concerns. It was with delight that Cllr Mutti and Cllr Nutt had installed the new mechanism to the play park gate. The rope on the balance beam had also been removed.

Tibbs Hollow

There were no issues, but it was requested that the PCSO paid a visit to the location, to ensure no illegal activities were going on.

a. P/LBC/2025/05251

Repointing of southern elevation and resetting of coping stones

The Parish Council supported this application.

b. P/FUL/2025/04958

New Farm House Southover Frampton DT2 9NQ

Retain change of use of land from agricultural to a mixed use of agricultural and the keeping of horses together with the siting of a field shelter

The Parish Council supported this application.

9. To receive and approve the financial reports and payments for authorisation

There were **9** payments (**PV's 15-23**) totalling **£ 3050.47**, that were approved and authorised for payment.

10. Initial discussion on Dorset Council Local Plan Consultation 2025 to include traveller's site

Members of the public and Councillors expressed reservations on the proposed site.

However, it was felt that the whole of the village was either not aware of the proposal, or the time frame of the meeting was too short.

Therefore, it was agreed to hold another meeting (with the Local Plan the only subject), to ensure the whole village had the opportunity to air their views.

The Clerk would also speak to Maiden Newton Parish Council to ascertain their direction of travel.

11. External audit report

There were no matters of concern. It was there agreed that the audit for 24/25 was concluded.

12. Painting of play equipment

It was agreed that the play equipment in the small children's play park needed a preservative prior to the winter.

The Clerk agreed to get some quotes from local tradesman.

13. Other Parish matters (not for resolution)

It was requested that the police speed van be requested due to continued ongoing concerns over excessive speeding through the village.

The Clerk would contact the CHO and PCSO.
