Minutes of Full Council held on **18<sup>th</sup> November 2025** in Frampton Village Hall.  
Meeting commenced at 7.00pm.

**FULL COUNCIL**

**1. Apologises for absence**

All Councillors were present.

**2. Declarations of pecuniary or other interests**

No declarations were made.

**3. To approve the minutes of the Parish Council Meeting held on 16<sup>th</sup> September 2025**

These were approved as a true and accurate record of the meeting.

**To approve the minutes of the Parish Council Meeting held on 07<sup>th</sup> October 2025**

These were approved as a true and accurate record of the meeting.

**4. Matters from the previous meeting(s)**

Local Plan consultation report sent into Dorset Council.

PCSO noted concerns at Tibbs Hollow and confirmed they were already monitoring.

Dorset Speed Watch confirmed they have added Frampton to the speed van sites but stated that Dorset had over 1000 site and only three vans.

Contractor would complete painting of play equipment upon a couple of rain free days.

External hedging and vegetation cut back at burial ground and allotments.

**5. Chair's update**

Chair had no matters to update.

**6. Public discussion period (agenda items)**

A debate ensued as to the next steps on the Dorset Local Plan Consultation.

It was suggested that all three Chairs from the relevant Parish Council's and the two Ward Councillors (along with the Member of Parliament), all sign a letter – vigorously stating opposition to the traveller's site and referring (officers of Dorset Council who were assessing the site), to the legal agreement signed off by a former Secretary of State.

Other members thought it best to let the procedure take its course as the site may not even be included in the draft local plan.

Members agreed that the signed letter could only add weight to the opposition to the site.  
Cllr David Taylor (Dorset Council) would take the lead on this.

Although the Parish Council had not heard anything back as yet, Councillors were content that we had done all we could at this stage.

Cllr Purse confirmed she would start phase 2 of the children's play park regeneration in the spring, with emphasis being placed on the multi-play.
